THIS CONTRACT is made and entered into this ___ day of June, 2020 between KANSAS CITY, MISSOURI, a constitutionally chartered municipal corporation (City), and NORTHEAST KANSAS CITY CHAMBER OF COMMERCE ("CONTRACTOR"). Whereby Contractor shall provide services, PART I, SPECIAL TERMS AND CONDITIONS, and PART II, GENERAL TERMS AND CONDITIONS to the City in accordance with the terms and conditions contained in this contract.

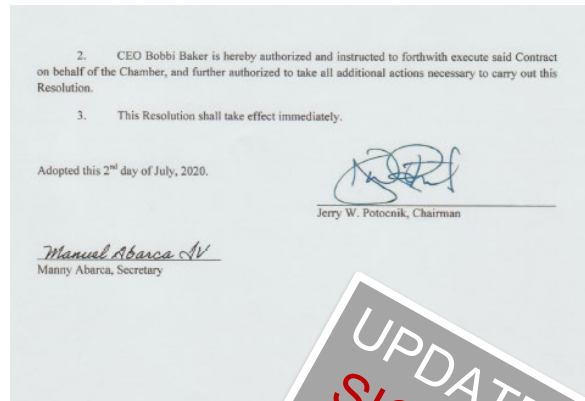
PART I
SPECIAL CONTRACT TERMS AND CONDITIONS

Sec. 1. Purpose. As a part of the Choice Neighborhoods Implementation Program, the City of Kansas City, MO has established a Commercial Façade Improvement Program that will assist eligible owners of commercial property and businesses in the Paseo Gateway neighborhoods to make exterior improvements to their property. The specific purpose of this Contract and the Project Area is attached as Attachment 2, and is incorporated herein by reference.

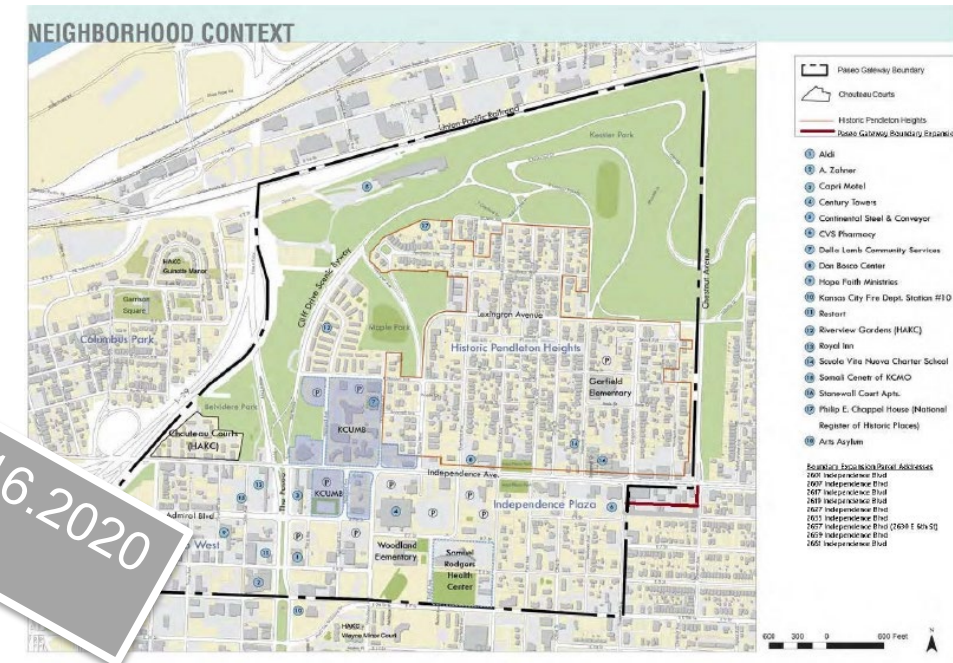
Sec. 2. Term of Contract. This Contract shall begin on June ___, 2020 and shall end no later than September 30, 2022. The Director is authorized to enter into an amendment to extend the term of this Contract and time of performance for this Contract.

Sec. 3. Maximum Compensation and Total Obligation.

A. Maximum Compensation. The maximum amount that City can pay Contractor and the total obligation which may accrue to the City under this Contract is **TWO HUNDRED TWENTY THOUSAND DOLLARS (\$220,000)**, pursuant to the budget approved by City. The execution and implementation of this Contract shall not create a general charge upon the General Revenues of the City, as envisioned by Section 82 of the Charter of Kansas City, Missouri. Any financial obligation is dependent upon the availability of funds under the line of credit issued to the Housing Authority of Kansas City by the United States Department of Housing and Urban Development pursuant to Grant No. MO7A002CNG114. No financial obligation shall accrue against the City unless such order bears the written statement of the City's Director of Finance that there is a balance, otherwise unencumbered, to credit of City under the above described line of credit from which payment is to be made.
